Introduction

The Newaygo Public Schools Board of Education is accepting bids from qualified vendors for delivery, rental and pick up of two portable walk-in refrigeration/freezer units. These units will be used outdoors to store perishable items and must meet our operational requirements for durability and efficiency.

Background

Newaygo Public Schools Food Service Department sponsors a Summer Food Service Program (SFSP) for children. Free meals will be made available to children 18 years of age and under or persons up to age 26 who are enrolled in an educational program for the mentally or physically disabled that is recognized by a State or local public educational agency. The meals will be provided without regard to race, color, national origin, age, sex (including gender identity and sexual orientation), or disability. The expansion of this program has surpassed our present equipment capacity. We require this equipment to ensure proper storage of food items.

The bid proposal will be accompanied by a sworn and notarized statement disclosing any familial relationship that exists between the owner or any employee of the bidder and any member of the Newaygo Public Schools Board of Education or the Newaygo Public Schools Superintendent. The District will not accept a bid proposal that does not include these sworn and notarized disclosure statements. All bidders must provide a reference sheet (such as the one provided). If you have another format to provide this information, please do so in that other format. The Board of Education reserves the right to accept or reject any or all bids, either in whole or in part; to award contract to other than the low bidder; to waive any irregularities and/or informalities; and in general to make awards in any manner deemed to be in the best interests of the owner.
